



Healthy Minds Training Accessibility Statement

This accessibility statement applies to Healthy Minds DfE-assured Senior Mental Health Lead Training to ensure inclusivity and accessibility.

Healthy Minds recognises that the experiences of individuals are unique, as is every educational setting and we wish to ensure an accessible learning environment which is responsive to your learning needs.

The service will continue to improve its accessibility and values your feedback to do so.

Our aims

To ensure equal access to the learning provided we have considered:

1. Communication

- You can expect timely communications to prepare for the event and a reminder two weeks prior to the start of the training
- We will provide a prompt and friendly response to any query or adjustment request
- Booking and registration forms are provided on a screen-reader friendly platform
- Alternative phone and email contact details are offered in case of unexpected circumstances on the day of the event

2. Training venue

- Our training venues are disability and accessibility friendly
- Participants will be given prior notice of the training venue, travel and parking options.
- · See information for Albion House which is our normal venue
- We can cater for different dietary requirements

3. Training platforms

4. Teaching delivery

- A variety of teaching methods are used to enhance all learning styles -PowerPoint presentation, discussions, sharing of practice, protected planning and reflection time and experiential activities.
- The trainer will flex to meet the needs of the cohort recognising the diverse needs of educational settings alongside participants and their individual experience.
- Cohorts are reminded to protect the confidentiality of schools or individuals within discussions, to enable greater freedom to discuss the strengths and needs of specific school communities

5. Teaching Materials

- All documents supplied will comply with UK government guidance https://www.gov.uk/guidance/publishing-accessible-documents
- Accessibility checker is conducted on all documents and presentations.
- Training handouts and resources are currently printed and provided to attendees at the start of the training day so learners can access these and refer to them during sessions
- Electronic resources can be requested to meet accessibility needs and will be available to all once the Healthy Minds Schools website is live.
- The Healthy Minds website is being developed in line with best practice accessibility WCAG 2.2 guidelines and will be navigable by keyboard
- Microsoft SWAY documents provide a mixture of further resources, videos
 and signposting to accompany training. When viewing a Sway document you
 can turn on Accessibility view. This view displays a high-contrast style for
 easier reading, disables any animations, and supports keyboard navigation as
 well as compatibility with screen readers.
- We do not plan to add captions to live video streams because live video is exempt from meeting the accessibility regulations.

6. Quality improvement

 Feedback regarding the quality of the training and accessibility arrangements are sought each session. Improvements are made at the earliest opportunity.

7. Personalised adaptations

- Healthy Minds welcomes requests for any provision or adjustment that will make events and programmes more accessible to you and enable you to learn most effectively
- Attendees will be formally asked to register any accessibility needs at registration and day 1 of the training and would welcome information from participants at any point during the training.

How accessible is the training?

Not all aspects of the training is currently accessible

- 1. We are aware that the current registration document is not clearly accessible via screen reader this will be updated by 1st August 2023
- 2. We currently inform participants where the training is held but do not make it clear how accessible the venue is, this will be added to the training advert by 1st September 2023 and be included within the registration information.
- Currently access to electronic training materials requires individual request; all
 participants will be able to access these documents through the Healthy Minds
 Schools website when it is launched
- 4. The Healthy Minds website is being developed in line with best practice accessibility WCAG 2.2 guidelines and will be navigable by keyboard
- 5. Currently some PowerPoint slides and documents do not meet the required accessibility standards these will be checked and updated by 1st September 2023
- 6. All trainers will receive updates regarding these accessibility standards by September 2023



Travel by public transport

Parking

- There is limited parking available at the venue. There are accessible parking spaces. The car park leads directly to the main entrance. Parking is free.
- The car park is situated behind the Albion House building through a square shaped archway opposite the Tesco Petrol Station on Savile Street.



Arrival

Path to main entrance

The main entrance and reception is at the back of the building, through the car park. Level access is available from the main entrance.





Main entrance

- The main entrance has level access.
- The door is 860mm wide (1670mm when open double).

Getting around inside

- We have 1 lift.
- You can get a lift to all floors.

Lifts to all floors

- The lift door is 759mm wide.
- The lift is 1340mm wide. The lift is 1400mm deep.
- The lift buttons have raised numbers or letters.
- The lift shows the floor number, at each floor.

Hels Public toilet

Accessible Toilet

- There is a public toilet for disabled visitors.
- The toilet foyer door is 770mm wide.
- The toilet door is 860mm wide.
- The direction of transfer onto the toilet is to the left.
- There is 800mm at the side of the toilet. There is 2500mm in front of the toilet. The toilet seat is 480mm high. The toilet has handrails.
